

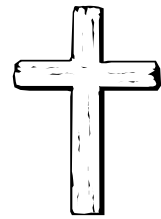

CDCA Information & Policy **School Year 2021/2022**

Philosophy & Goals of Christian Day Child Academy

Our goal is to provide a Christ-centered nurturing environment where children can learn, discover and create. We believe that God's Word, the Bible, is the foundation of all learning. We desire that like the child, Jesus, our students will "grow in wisdom, in stature and in favor with God and man." (Luke 2:52) Our curriculum areas include: Bible verses, pre-reading and math activities, social studies, health, science, large and fine motor development, outdoor play, music, stories, and creative art activities. Our daily schedule includes both creative playtime and structured activity time. The center's program plan is available for review on request.

Age of Children, Days & Hours of Operation

Christian Day Child Academy is licensed for preschool children, ages 3 years through 5 years, 5 days a week (Monday through Friday.) Sessions are 9:15 a.m. to 11:45 a.m.

Parent Conferences & Communication

Parent conferences are planned and offered for each student. A pre-admission conference (form) and two parent /teacher conferences during the school year (fall & spring) are offered informing parents of the child's developmental progress intellectually, physically, socially and emotionally. A newsletter is sent home each month as well as health information letters as needed. Daily information will be written on a parent message board in the arrival area. Parents will receive school information emails. Updates of school information will also be on our website at www.christiandayacademy.com

Insurance

Christian Day Child Academy carries liability coverage on all children and personnel on the premises.

Health Care Summary & Immunization Form

Immunization records and health care forms are required on the child's first day of attendance at school. If these forms are not submitted as required, the child will not be able to attend until the forms are brought to school.

Absent & Illness Policy

If your child will be absent from school, please notify the school office. If your child is absent due to illness, please let us know as soon as possible. We are required to notify all parents of communicable diseases. If a student, parent or staff member has a COVID- 19 diagnosis, CDCA staff will contact the Minnesota Department of Health and follow their directions. Parents will be informed through a phone call, text or email.

Daily temperature checks/health checks will be conducted on arrival at school.

COVID -19 Exclusion Policy:

- **Any symptoms consistent with COVID-19, requiring a child to stay home are: fever; chills; muscle pain; headache; sore throat; new loss of taste or smell. Also, if parents are sick with any of these symptoms, your student must stay home.**

If you have more than one child and they are home with any of the above symptoms, your student must stay home.]

Other Illness Exclusions:(requiring a student to stay home)

- **Diarrhea**
- **Vomiting**
- **Cold with heavy, yellow or green nasal secretions**
- **Sore throat**
- **Coughing**
- **Eye redness and/or drainage should be checked by a doctor to rule out infection**
- **Rash (unless caused by an allergy)**
- **Any contagious illness**
- **Child not feeling well, such as lethargic behavior.**

If a student becomes ill while at school:

The child will be separated from the other children until the parent arrives. Please call the school when you arrive to pick up your child. Two emergency contacts must be listed in the child's file. If your child becomes ill while at the center, the parent will be contacted and expected to pick up the child as soon as possible.

Allergy Policy

The school must be informed of any allergies that a student has and a plan will be made for prevention and response to an allergic

reaction. All staff have been trained in Allergy Prevention and Response by Minnesota Medical Training. **Each student with allergies must have an Individualized Child Care Plan (ICCP) signed by their health care provider. Forms are available at the school.**

First Aid Administration & Authorization

Parents are required to complete an emergency medical information form for their child including their preference of doctor, hospital, clinic and dentist with complete contact information. CDCA's source of emergency medical care is calling 911. Parents must authorize Christian Day Child Academy staff to administer first aid. Staff shall call the parent and 911 as deemed necessary. All staff have been trained in CPR and First Aid.

Medication

No medication will be given to a child at school. Exception to this rule – please contact the director for forms that must be signed by the parent and the child's doctor.

Snacks

Snack and 100% juice are served mid-morning. All snacks will be provided by the school. For the child requiring a rigid diet because of severe diabetes, sodium restriction, allergies, etc., snack must be brought from home. Please talk to the director about details related to bringing snacks from home. **Parents must inform the school if their child has food allergies and a written allergy action plan must be in place before the first day of school.**

School Clothes

Children should dress in comfortable play clothes for school. Children should not wear shirts that depict weapons, violence, skulls or any themes not in keeping with the Christian philosophy of our school. School t-shirts will be provided for the students. Tennis shoes are encouraged for outside play.

Holiday Parties

Throughout the school year all classes have 4 holiday parties – Thanksgiving, Christmas, Valentine’s Day, and Easter. Teachers will be planning and staffing the parties. **If the policy for having parents/volunteers in the classroom changes, parents will be informed.**

Behavior Guidance & Disciplinary Procedures

Teachers will use positive guidance, redirection and the setting of clear-cut limits that encourage the child’s own ability to become self-disciplined. Teachers will encourage children to respect other people, property and learn to be responsible for their actions. Teachers will guide children to develop self-control and appropriate conduct in relationship to peers and adults. Teachers will use discipline that is consistent, clear and understandable to the child.

Discipline Action Standard:

- 1) Teacher/child discussion of the problem situation.
- 2) Statement of expectations and consequences.
- 3) Teachers consistently following through with the stated consequences.
- 4) Inform parents of the behavior situation and develop a behavior plan.

In rare instances, it may be necessary to suspend a child from the program due to disruptive behavior. The following procedures will be administered as needed:

- Step 1: Teacher talks with the child and attempts to modify behavior. Behavior is documented.
- Step 2: Teacher talks with the parents and child and involves the family in bringing about the desired behavior change with a behavioral plan.
- Step 3: If disruptive documented behavior continues, the director talks to the child and parents and discusses the behavioral plan.
- Step 4: If disruptive documented behavior continues, the child is excluded for one day.
- Step 5: If the child still exhibits unacceptable documented behavior, the option of extra teaching staff

on a trial basis might be provided to give one-to-one support for the child upon parents' consent. This cost would be the responsibility of the parents – above regular monthly tuition costs.

- Step 6: If the child still exhibits unacceptable documented behavior, he/she may not be allowed to continue in the program.

If you have any questions about our behavior guidance procedures, please talk to your child's teacher or the director.

Pets

Pets or pet visits in the classroom or school building are not allowed for allergy and safety reasons.

Toys

Students are not allowed to bring toys into the classroom.

Volunteers/Visiting the School

As part of our COVID Safety Plan, parent volunteers are not allowed in the classroom at this time. Parents will be informed if this policy changes. Please call the school at anytime if you want to pick up your child and he/she will be brought upstairs to the arrival area with a teacher.

Outdoor Play

Weather permitting we will play outside each day at school. Please dress your child appropriately for outside play. Please label all outerwear.

Field Trips

We will not be going on field trips through December 2021 because of our COVID Safety Plan. If we are able to safely resume field trips, parents will be informed and a field trip permission form will be required to attend the trip.

Arrival & Dismissal Policy/ Safety Policy

On arrival at school parents should bring their child to the double doors at the front of the church building. Each student will have their temperature taken and a health check. The student will be escorted to their classroom by a teacher. On dismissal parents should arrive again at the south church double doors wearing a mask and students will be brought upstairs to depart with their parent through the north church doors. Signs will be used to help direct parents and show the flow of traffic on arrival and departure. All parents should social distance during school arrival and departure.

Parents are required to make known in writing authorized personnel bringing the child to and from the center. Parents are required to notify the center if someone other than a parent is allowed to pick up the child from the center. The child will not be released until the teacher is given permission by the parent. Parents are responsible to be alert to weather conditions while the child is in attendance at the center. Parents are encouraged to pick up their child from the center at any time they feel the weather is threatening. Please call the school whenever picking up your student early and a teacher will bring him/her up to the dismissal area. **Weather related school closings will be announced on our website at www.christiandayacademy.com or email the school with questions at cdca@mnvalley.org**

Emergency Plans

Monthly fire drills and tornado drills (in the fall & spring) are practiced at school. Safety drills will also be practiced. A copy of the CDCA Emergency Plan will be available to all families at the time of enrollment.

GRIEVANCE POLICY & PROCEDURE:

A parent may bring a grievance (if unhappy or have questions) about the manner in which a situation involving their child is handled to a staff person. The staff person will listen attentively and discuss the situation with the parent. The staff person would then immediately inform other staff of the issue. The full staff would meet and discuss the situation and review reasons for actions according to the program's standards. After discussion, the head teacher would contact the parents and share the staff's discussion. If the parent is still not satisfied, he/she may contact the director. A conference with the parents, staff and the director would be set up to address the issue in the best interests for all concerned. The grievance of each issue shall be addressed and resolved within the week of notice.

CHILD PROTECTION LICENSING REGULATIONS

Recent licensing regulations now require parents to be informed of policies and procedures regarding the Maltreatment of Minors Act. Teachers in a licensed facility are legally required to report suspected child maltreatment, but any person may voluntarily report

abuse or neglect. If you know or have reason to believe a child is being or has been neglected or physically or sexually abused, you may make a report to an outside agency such as the police (telephone: 911) or the Child Protection Agency (952-891-7459).

Tuition Policy

Tuition is based on the actual cost of operating the school. CDCA depends on each month's tuition to pay current expenses and staff salaries. All children attending CDCA will pay full tuition each month unless financial aid provisions have been arranged through the director and board.

Parents must sign a financial agreement before the school year begins.

- 1) Parents agree to pay the first month's tuition by the first day of school.
- 2) Tuition is due the first day of each month.
- 3) If monthly tuition is not paid by the 10th of each month, you will receive a late notice.
- 4) If monthly tuition is not paid by the last day of the month, you will be required to meet with the director and/or CDCA board to discuss your financial commitment.
- 5) If monthly tuition is not paid by the last day of the subsequent month, your child may be dismissed from the preschool.
- 6) Families with multiple children enrolled will receive a 5% tuition discount for 2nd, 3rd, etc. children.
- 7) Members of Minnesota Valley Church will receive a 10% tuition discount.
- 8) Only one option of 6 or 7 can be used.

Tuition: 2-day classes - \$160 3-day classes - \$210

NON-DISCRIMINATORY POLICY

Christian Day Child Academy admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship programs, and any school administered programs.

BIBLICAL LIFESTYLE POLICY

Christian Day Child Academy (CDCA) is a religious institution providing an education in a distinct Christian environment, and it believes that its biblical role is to work in conjunction with the home to mold students to be Christ like. On those occasions in which the atmosphere or conduct within a particular home is counter to or in opposition to the biblical lifestyle the school teaches, the school reserves the right, within its sole discretion, to refuse admission of an applicant or to discontinue enrollment of a student. This includes, but is not necessarily limited to, living in, condoning, or supporting sexual immorality; practicing homosexual lifestyle or alternative gender identity; promoting such practices; or otherwise having the inability to support the moral principles of the school (Leviticus 20:13a, Romans 1:27, Matthew 19:4—6).

Letter Activities for All Classes

Each week children in all classes can bring in magazine pictures of things starting with the “letter of the week.” The children will put the pictures on a poster, which the teachers will review with the children at the end of the week. Each student will also have a turn to take home the “Letter bucket”. Please keep this simple! Items (5) placed in the bag should be small and can also be drawn or cut out of a magazine. (Example, L week – a lego, lint, library book or card, something lavender, ladle, lace, leaf, etc.) Please see us if you have any questions. This should be a fun activity for the class and at the same time reinforce the letter sounds. Learning is fun! Thank you for helping your child with this activity!

CDCA Staff

Learning at Home

Parents are a child's most important teachers. Children need a variety of experiences as they progress towards kindergarten readiness. Here are a few suggestions of activities that you might want to do with your child.

- Read, read, read to your child. Bring books with in the car for your child to look at or in your purse while you wait with your child for appointments.
- Record the books you have read to your child on our preschool reading form and have your child return it to school for a sticker. The forms will be kept in your child's portfolio throughout the school year.
- Make labels for objects in your home in order to provide a print rich environment.
- Work on rhyming – “What rhymes with hat?” as you are waiting at the stop light or in the grocery line. Understanding rhyming has a correlation to beginning reading.
- Ask your child questions when you are reading a story.
- Have your child dictate a story to you & write it down. Have your child draw pictures to go with his/her book. Bring it to school to show his/her teachers!
- Provide activities for your child to develop hand/finger strength – important for writing and scissor skills. Ideas: playdough, pinch bubble wrap between thumb and fingers, use spray bottles outside with water (my grandchildren love this!), use eyedroppers for art projects, rip paper into small pieces for an art project or have your child cut out coupons.

- Provide activities for your child to develop shoulder strength and stability, which is also important in writing. Ideas: Paint large boxes (this works well outside!), write on a chalkboard or paper mounted on a wall or vertical surface, digging in the dirt or shoveling snow, stacking large blocks or pulling peers in a wagon.
- Help your child to recognize their name, know the letters in their name and to begin printing their name.
- With supervision help your child begin to cut with scissors.
- Limit TV and computer time. When your child does watch TV, watch with them and talk about what they have seen.
- Help your child learn their full name, address & phone number.
- Encourage social development by inviting a friend from their class to your home for a play date.
- Talk about colors, shapes, letters & numbers during your daily routine. What letters do you see on the cereal box? How many crackers do you have left to eat? What color is a stop sign? What shape is your cookie?
- Pretend with your child – Let's pretend we are riding on a bus. Where do you think we are going?
- Children learn through play – have fun!!!
